## **Coral Gables, Fla., Attorney Brian H. Bieber Elected to Board of Directors of National Criminal Defense Bar Assn.**

**Washington, DC** (Aug. 25, 2009) – Coral Gables, Fla., attorney Brian H. Bieber was elected to the Board of Directors of the National Association of Criminal Defense Lawyers (NACDL) at the Association's 51<sup>st</sup> Annual Meeting in Boston, Mass., this month. He is a member of the Florida Association of Criminal Defense Lawyers and has previously served on NACDL's Membership Committee. Bieber is also NACDL's State Membership Chair for the State of Florida.

Licensed to practice law in both Florida and the District of Columbia, Bieber is also admitted to practice before the United States Supreme Court, the Second, Third, Fourth, Fifth, Sixth, Eighth, Ninth, and Eleventh Circuit Courts of Appeal. In recent years, Bieber has been both a finalist and a recipient of *Daily Business Review's* "Most Effective South Florida Lawyer Award." Over the years, he has been featured in the *New York Times*, *Wall Street Journal*, *National Law Journal*, *Miami Herald*, *South Florida Sun-Sentinel*, *Palm Beach Post*, *Ocala Star Banner*, and other daily newspapers across the country. In addition, Bieber has appeared on *CNN*, *Telemundo*, *48 Hours*, *Fox News Channel* and other news outlets, both in the U.S. and abroad.

Bieber, a named partner at the firm of Hirschhorn & Bieber, P.A., from 2000 to present, began practicing law at Hirschhorn, P.A. from 1994-99.
