He has extensive experience in successfully defending scientifically/medically intensive criminal allegations, including shaken baby syndrome, pediatric head injuries, sexual assault cases with medical evidence, and cases involving DNA evidence. Once called the most hated man in America, Baez wears that title like a badge of honor. In order to more effectively cross-examine forensic experts, he finds it important to learn the science himself, that is why he has completed hundreds of hours of training dedicated to areas of forensic science such as DNA, Blood Pattern Analysis, trace recovery, forensic pathology and entomology, among others.
