On August 12, 2022, the NACDL Foundation for Criminal Justice (NFCJ) will hold its annual fundraiser in honor of Albert J. Krieger – Friday night before the 2022 NACDL Annual Meeting.

In addition to his many accomplishments, Albert was a leader in the formation of NACDL, a past president of the organization, a recipient of two of NACDL's highest honors – the Robert C. Heeney Memorial Award and the Lifetime Achievement Award – as well as the recipient of many other awards and accolades.

Albert passed away in 2020, but the results of his work and passion will live on in perpetuity. We are grateful that Albert's family, friends, and colleagues will join us to recognize his commitment to excellence within the defense bar.

Convening in the Circle Ballroom at The Breakers in Palm Beach, Florida, this early evening event will include a cocktail reception, silent auction, open bar, heavy appetizers, and a short presentation.

A portion of the funds raised during the evening will support the Albert J. Krieger Fund with the NFCJ, which was established in 2020 to support work that will honor Albert's memory.

Funds raised through this event support the charitable work of the NFCJ. Work supported by the NFCJ includes:

- **Minority fellowships** to promote diversity in the criminal defense bar.
- **The Return to Freedom Project**, which includes numerous pro bono projects to secure reduction of excessive sentences and other back-end relief.
- Various **strategic initiatives** to promote sentencing reform, end the trial penalty, and nurture ongoing efforts to oppose overcriminalization.
- **The Full Disclosure Project** to disrupt the culture of secrecy that systematically and pervasively shields law enforcement misconduct by changing police secrecy laws and empowering the defense community to track police misconduct.
