San Antonio, Tex., Attorneys Leslie Sara Hyman and Meagan M. Gillette Awarded Champion of Justice Awards by National Criminal Defense Bar

Washington, DC (Aug. 26, 2010) – At its 52nd Annual Meeting in Toronto, Ont. this month, San Antonio, Tex., attorneys Leslie Sara Hyman and Meagan M. Gillette were honored with Champion of Justice Awards by the National Association of Criminal Defense Lawyers (NACDL). Hyman and Gillette received Champion of Justice Awards for their *pro bono*, humanitarian work in securing asylum for an Eritrean refugee under the Convention Against Torture.

Hyman and Gillette's client had fled Eritrea after being tortured, beaten and arrested simply for engaging in prayer. After her long journey to the United States, she was detained and slated for deportation. That was until a commercial litigator and an intellectual property attorney from Cox Smith's San Antonio office became involved. Their hard work included learning complex immigration law, preparing their client's application for asylum and withholding of removal and obtaining documentation necessary to support the client's identity and credibility. Hyman and Gillette developed this legal competence to help immigrants who are faced with a daunting administrative and legal process and are without resources to engage counsel.

A graduate of Brandeis University and the University of California Hastings College of the Law, Leslie Sara Hyman is shareholder at Cox Smith in San Antonio, Tex.
