# I. CRIMINAL RECORDS HELP

**Apply for Criminal Records Help**  
if you have one of the following:

*An arrest that was never charged*

*An arrest where charges were dismissed*

*An arrest that was dismissed after successful completion  
of a pretrial diversion program*

*A successfully completed deferred adjudication*

*A first-time misdemeanor conviction*

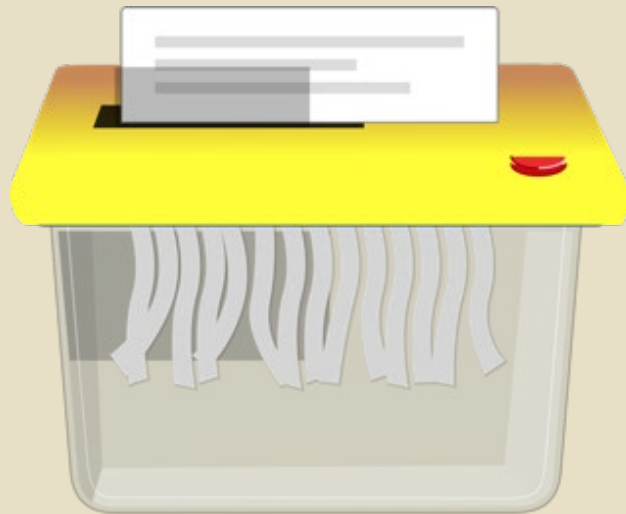
*An unlawful carry of weapon conviction*

**Felony Convictions Not Eligible.**

# Relief from Criminal Records in Texas

## Expunction

**Erases or destroys** records of an arrest or offense



## Orders of Nondisclosure

**Restricts** what entities have access to criminal records

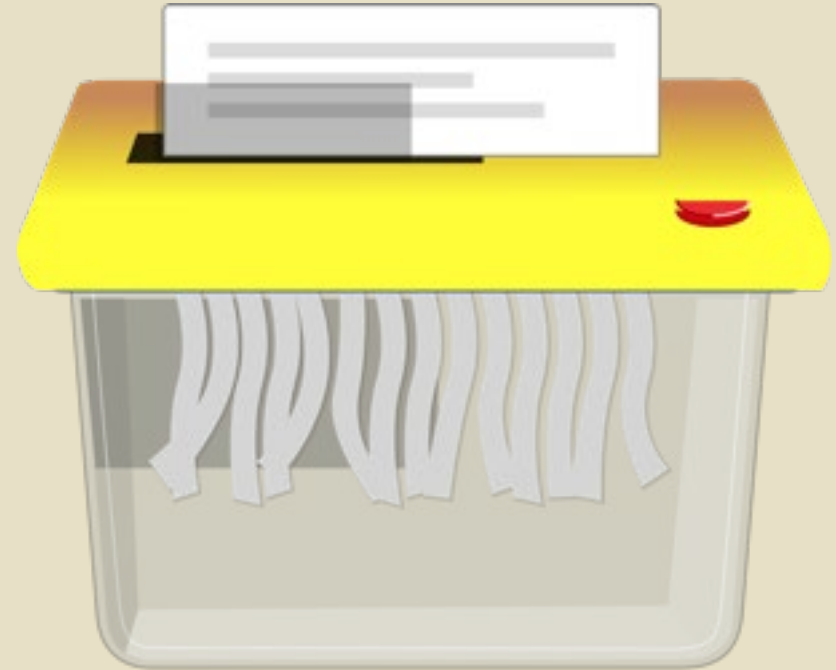
# Expunctions

---

## ***Completely Shred Record***

MAY be eligible:

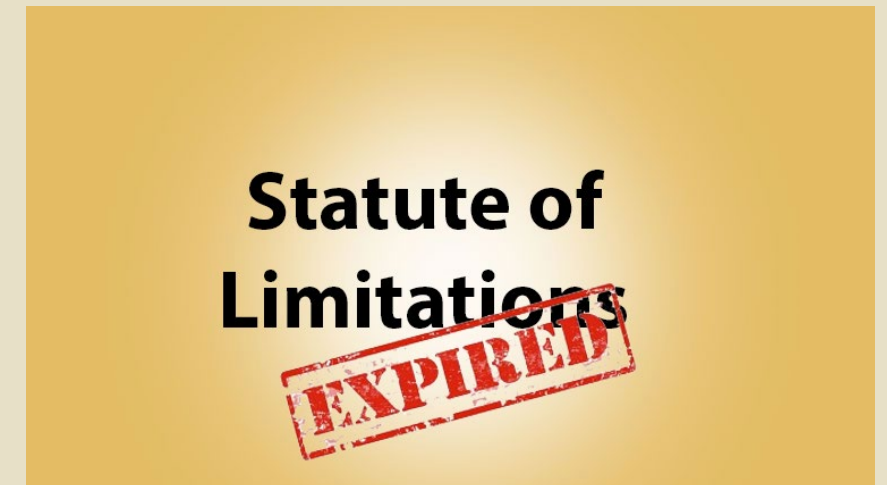
- Arrested, Never Charged
- Dismissed Charge
- Pretrial Diversion/Intervention
- Acquitted
- Pardoned
- (New!) Unlawful Carry of Weapon Conviction





# Statute of Limitations (SOL) has run

Murder; Agg sexual assault; Indecency with a child; human trafficking	No SOL
Injury to a child	10 years from 18 <sup>th</sup> bday of child
Estate/Gov't theft; Arson; Sexual Assault	10 years
Health Care Fraud; Credit/Debit Card Abuse	7 years
Felony theft or robbery; Insurance Fraud	5 years
All other felonies	3 years
Misdemeanors	2 years

# Orders of Nondisclosure

---

## *Seals / restricts Record*

MAY be eligible:

- Successful Completion of Deferred Adjudication
- First-Time Misdemeanor Conviction

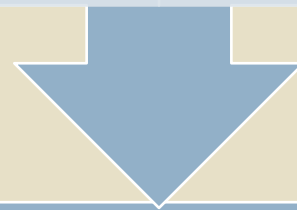


# Other Nondisclosure Requirements



# Criminal Record Clearing in Texas is *NOT* Automatic.

In a petition-based record-clearance system, just **6.5%** of eligible people successfully get their records cleared.

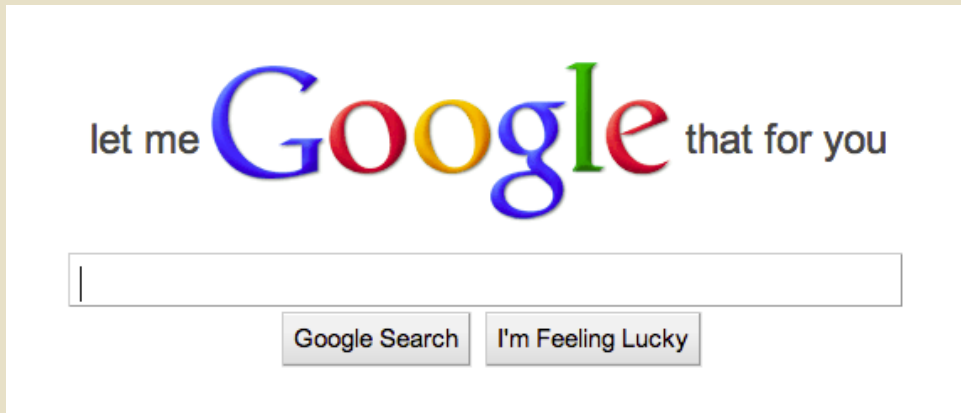
