18 Having good cause, the Court hereby grants Defendant’s application.
19 The current trial date of December 15, 2025, and the pretrial conference of
20 December 1, 2025, are hereby vacated pending the Ninth Circuit Court of
21 Appeal’s resolution of the government’s appeal in *United States v. Blandon-*
22 *Saavedra*, 25-7261 (9th Cir. 2025). The future trial date and pretrial
