





#### The 4 Rules for Storytelling in Cross

- 1 Only Leading Questions
- 2 Only 1 new fact per question
- 3 Only short questions
- 4 Only leading to a specific conclusion

### **ONLY LEADING QUESTIONS**

#### Leading questions = answers

- How do you feel about drinking?
- Do you like to drink?
- You like to drink?
- You drink?
- You like it?

## ONLY ONE NEW FACT PER QUESTION

## One new fact per question solves problems.

- Better witness control.
- Clarity of the answer.
- Easier impeachment.
- More detail
- Repetition w/out being repetitive


### **ONLY SHORT QUESTIONS**







## ONLY QUESTIONS THAT LEAD TO A SPECIFIC GOAL



#### What goes in

What the witness MUST say sourced

What the WILL give you logic, personality, character, your experience

#### What stays out

Anything that doesn't lead to your conclusion

What the witnesss can NEVER say one question too many

#### **HGN LIGHTS**

28:23 strobe lights can cause HGN you had strobe lights on your car 26:7 the lights are red and blue they are bright 27:17 they are designed to be seen from a long way off the strobe lights are very effective 28:4 they reflect off of everything your car is parked behind Mr. W's car 26:10 those strobe lights are pointed at the rear of his car 26:10 you had him facing the rear of his car 23:3 your flashing lights were reflecting off of his car So, your lights caused his HGN your lights caused his HGN

#### Worth and Value of Story

If you lie well enough you get out of prison

#### **WORTH AND VALUE**

- 1536 you called Aurora police on the phone
- 1536 you talked to Det. Dailey
- 1536 you called back a week later
- 1536 to ask if he had talked to DA
- 1536 told you he had
- 1536 He told you "They will not do anything, they won't approach anybody, won't do anything until they know what you have"
- 1538 You were worried about telling your story before you knew what it was worth
- 1539 You told him you were skeptical because once you said it they could do whatever they wanted
- 1538 Detective told you it wasn't going to be worth anything unless you testified

#### Worth and Value II

- 1538 Told you that was what your protection was
- 1452 the DA was going to have to determine the "worth and value" of the information

worth and value means how much you get in exchange

the better the information, the more valuable it is

the more value you get

Usually Chronological is **NOT** Best


