## **Disproportionately Black**

## Earl Smith, PhD (2020)

Black youth are currently confined in the criminal punishment system 3X white youth<sup>1</sup>

Blacks get longer sentences than whites<sup>2</sup>

Blacks are confined in solitary confinement more often than whites<sup>3</sup>

Blacks (men) comprise a larger percentage of those exonerated than they are represented in the prison population<sup>4</sup>

Black women sterilized more often than white women<sup>5</sup>

Black people in the United States have a disproportionately higher death rate from tobaccorelated illnesses than other racial and ethnic groups<sup>6</sup>

Black mothers' infant mortality is the highest of all groups in US; a baby born to a Black mother in Mississippi is more likely to die before its first birthday than a baby born in any other western hemisphere country except the Dominican Republic, Guyana, Bolivia and Haiti.<sup>7</sup>

Blacks are more likely to experience "stop & frisk"<sup>8</sup>

Blacks are more likely held for not being able to pay bail (or fines)<sup>9</sup>

Black officers disproportionately convicted for murder<sup>10</sup>

Black undercover officers are more likely to be killed by white officers than the reverse<sup>11</sup>

Blacks are paid less than whites for same jobs<sup>12</sup>

Blacks in places like Ferguson and Chicago (*Chicago Fines, Fees & Access Collaborative*), are targeted by the city's ticketing and debt collection practices that disproportionately affected low-income and black neighborhoods<sup>13</sup>

Disproportionately, more than any other race/ethnic group, Blacks are harmed by the war on drugs<sup>14</sup>

Disproportionately, Blacks don't have equitable access to the burgeoning cannabis industry<sup>15</sup>

Disproportionately, more than any other race/ethnic group, Blacks don't have equal access to the housing market<sup>16</sup>

Blacks disproportionately experience absolute exclusion from 'high-tech' jobs in Silicon Valley<sup>17</sup>

Blacks disproportionately experience 'civil death' after convictions & incarcerations;<sup>18</sup> (Sonia Sotomayor wrote that anyone who is arrested "will now join the 65 million Americans with an arrest record and experience the 'civil death' of discrimination by employers, landlords, and whoever else conducts a background check." 136 S. Ct. 2056, 2070 (2016), Sotomayor, J., dissenting).

Blacks disproportionately offered less pain medicine than whites by medical doctors<sup>19</sup>

Blacks are disproportionately more likely than whites and other race/ethnic groups to be assigned e-carceration digital monitors like ankle and risk bracelets.<sup>20</sup>

Disproportionately, Black women continue to be incarcerated at twice the rate of white women.<sup>21</sup>
