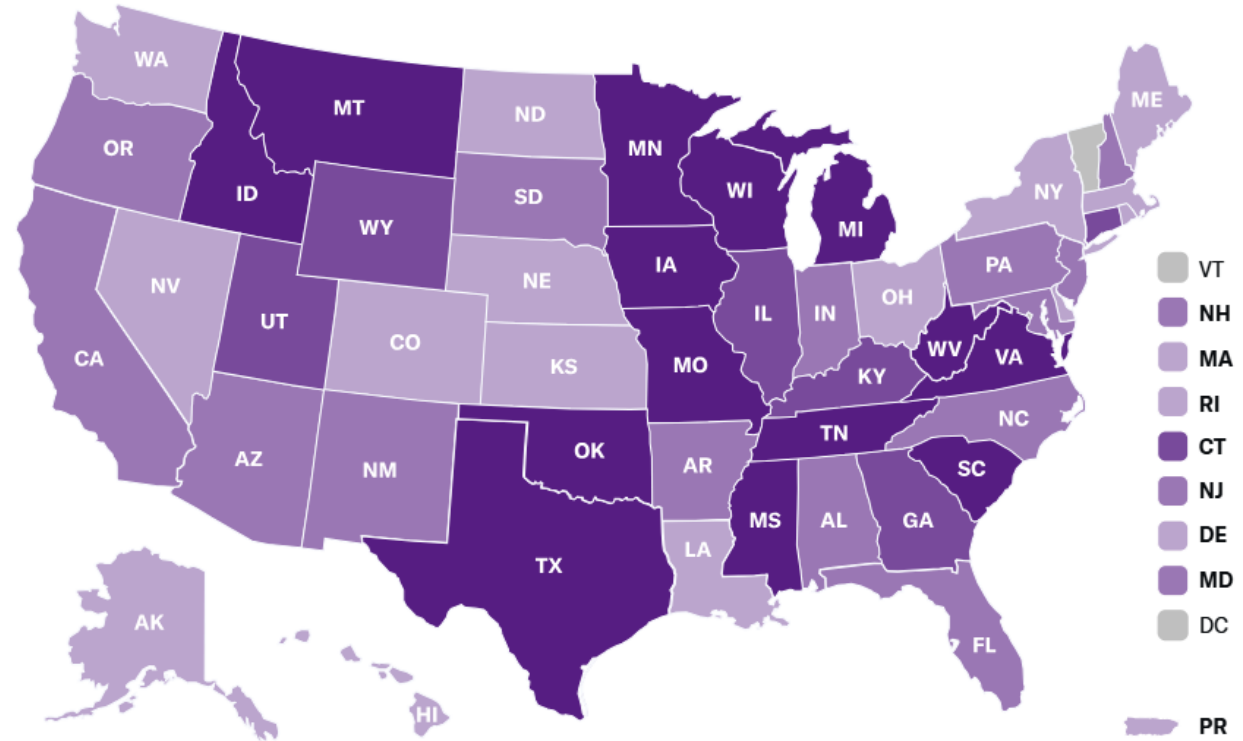

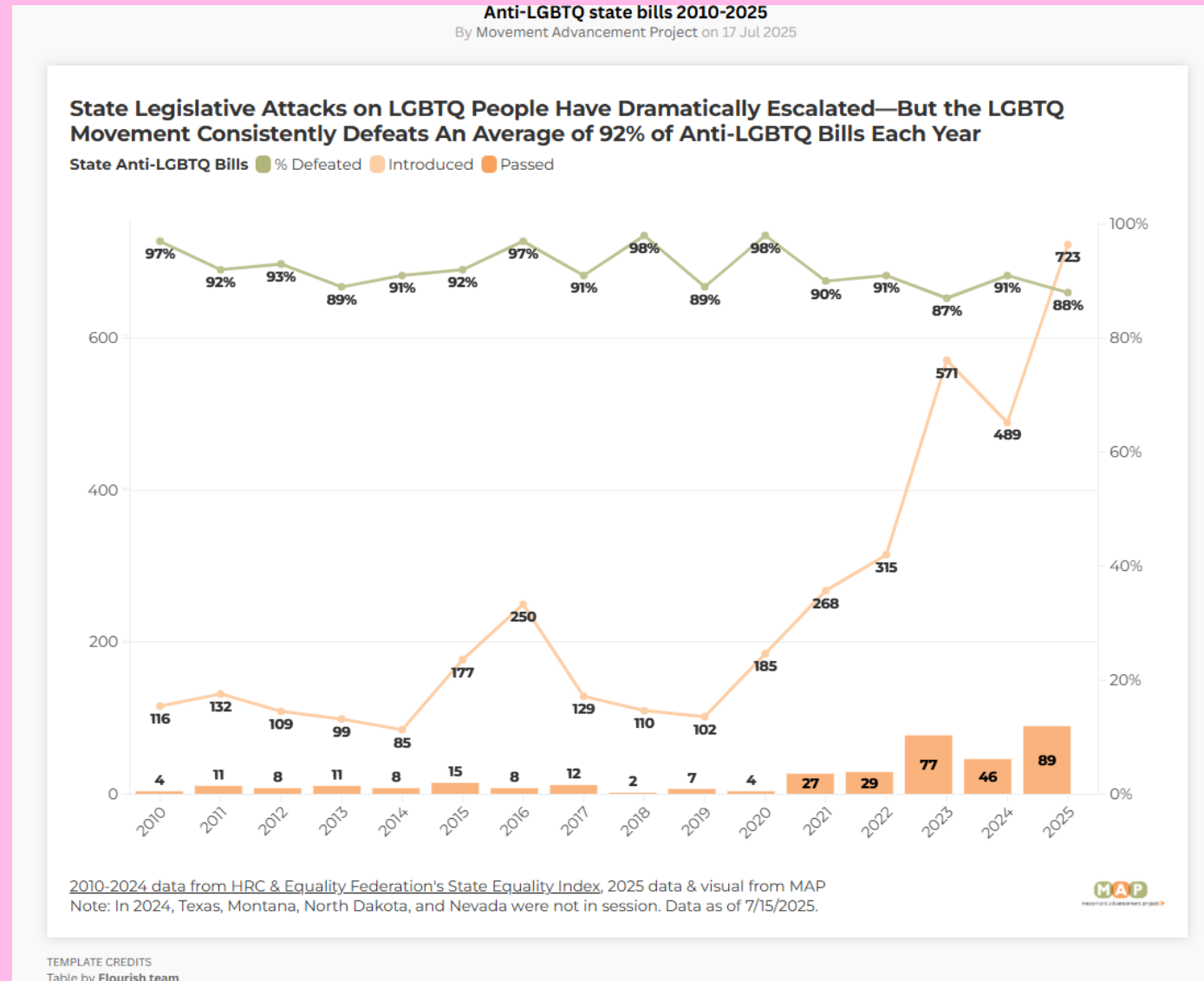
Choose a state on the map to show the different bills targeting LGBTQ Rights and take action. While not all of these bills will become law, they all cause harm for LGBTQ people.

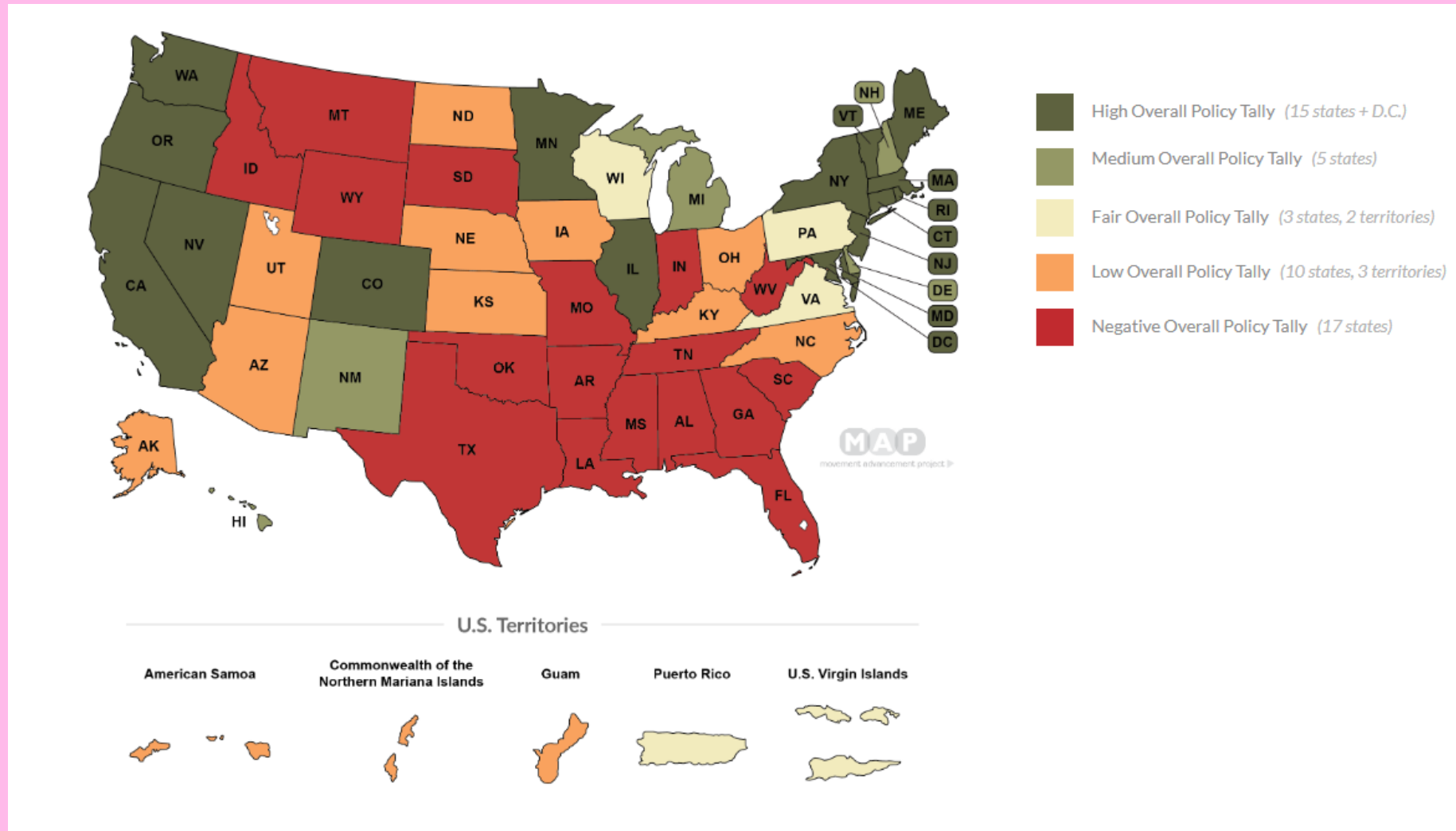
TRENDS IN BILL TYPES 2025

Bill Types
• Narrowly defining “sex” in conflict with <i>Bostock</i> and to try and exclude transgender people
• Blocking medically necessary care for transgender people who are incarcerated
• Preventing state funds from paying for Medicaid for state employees for gender affirming care
• Banning transgender athletes from playing on sports teams matching their gender identity
• Banning gender affirming care for transgender youth (in new and more expansive ways)

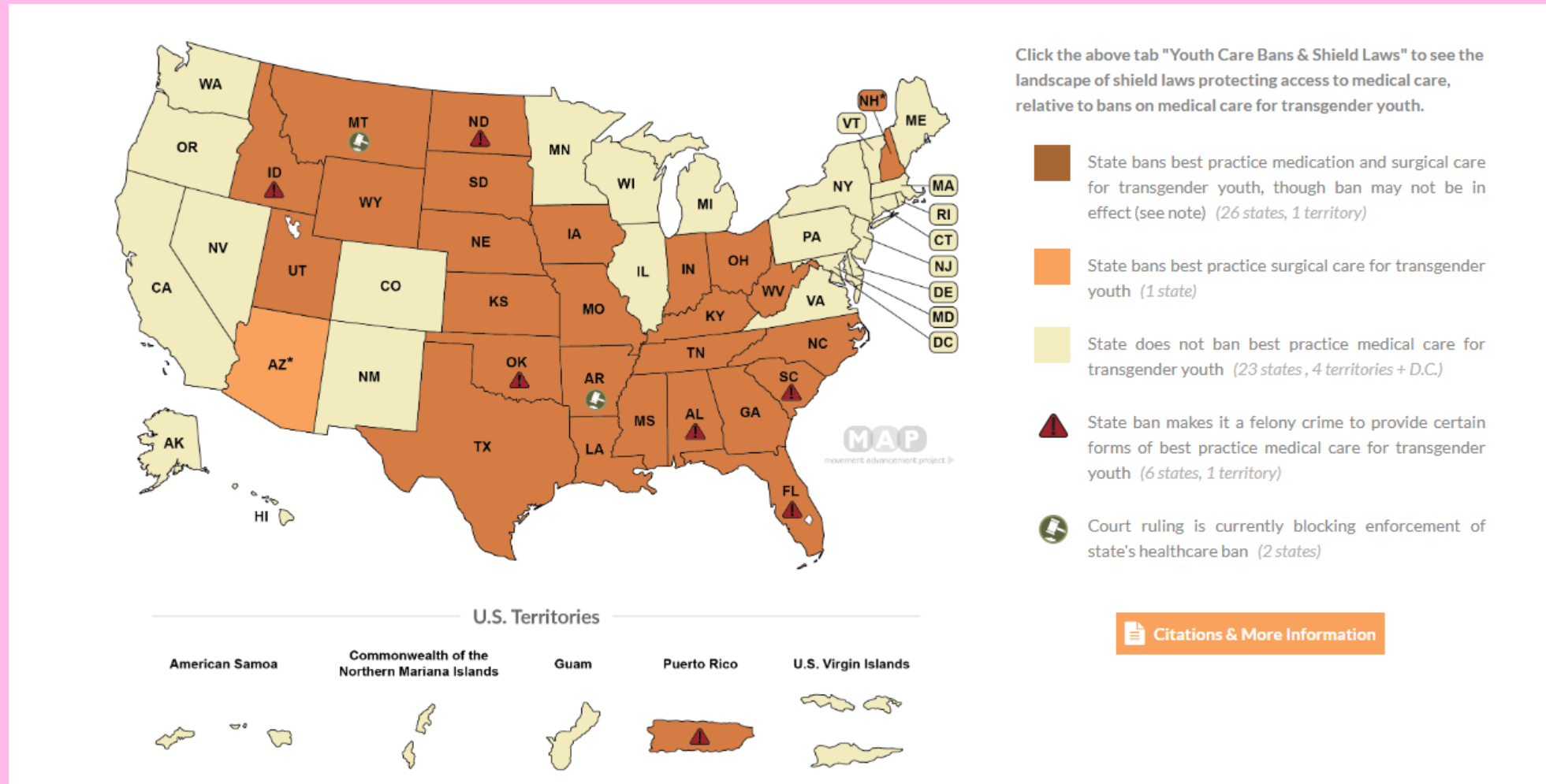
PREDICTED TRENDS IN BILL TYPES 2026

Bill Types
• Blocking medically necessary care for transgender people who are incarcerated
• Weaponizing funding streams unless an anti-trans policy is adopted OR unless nondiscrimination protections that include trans people are repealed (e.g., Columbia, SC)
• Expanding attacks on access to medically necessary care for transgender <u>adults</u>
• Continued efforts to narrowly define “sex” in conflict with <i>Bostock</i> and to try and exclude transgender people from spaces, especially restrooms and facilities
• Restricting access to accurate ID documents (drivers licenses and/or birth certificates)

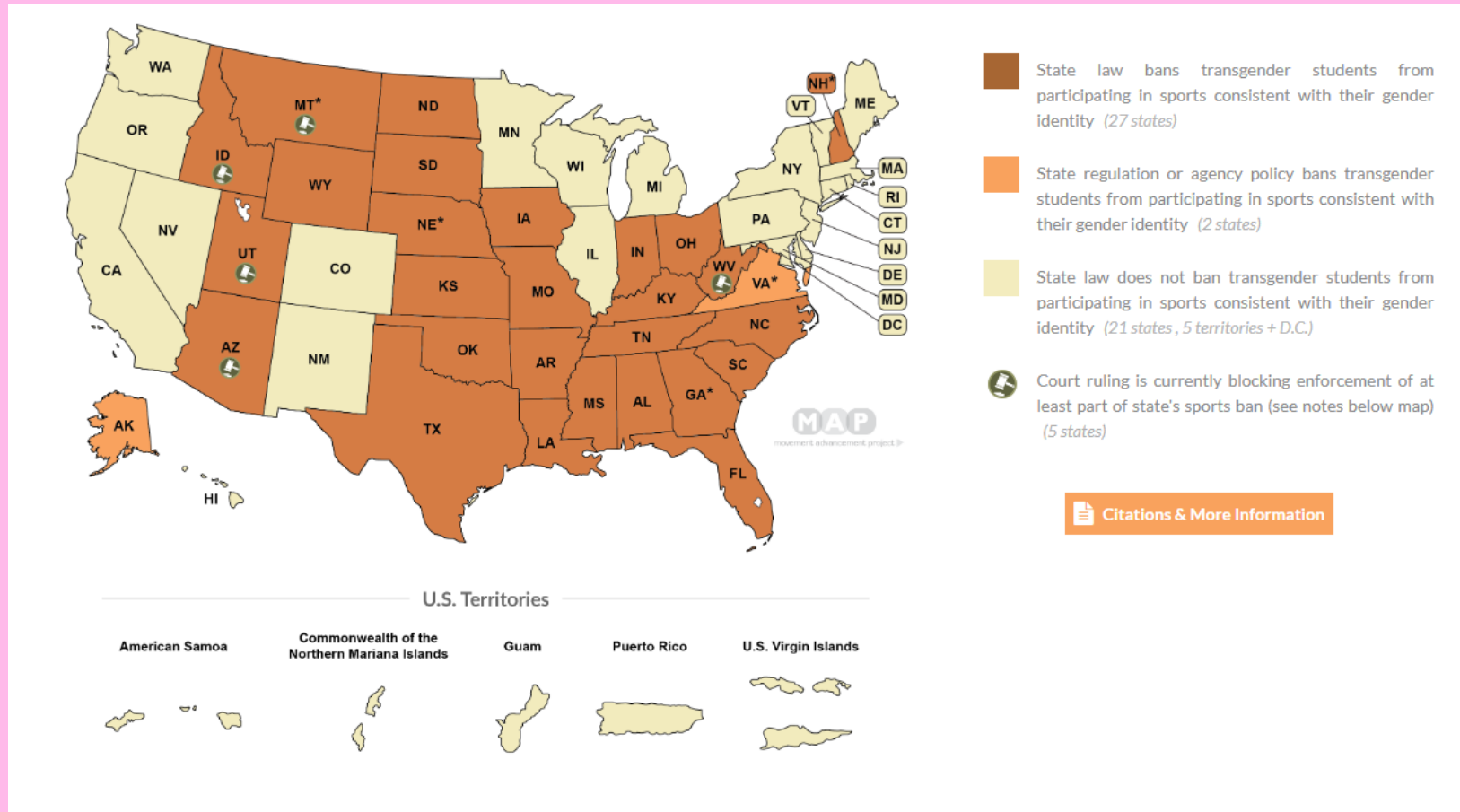
STATE-BY-STATE EQUALITY SNAPSHOT



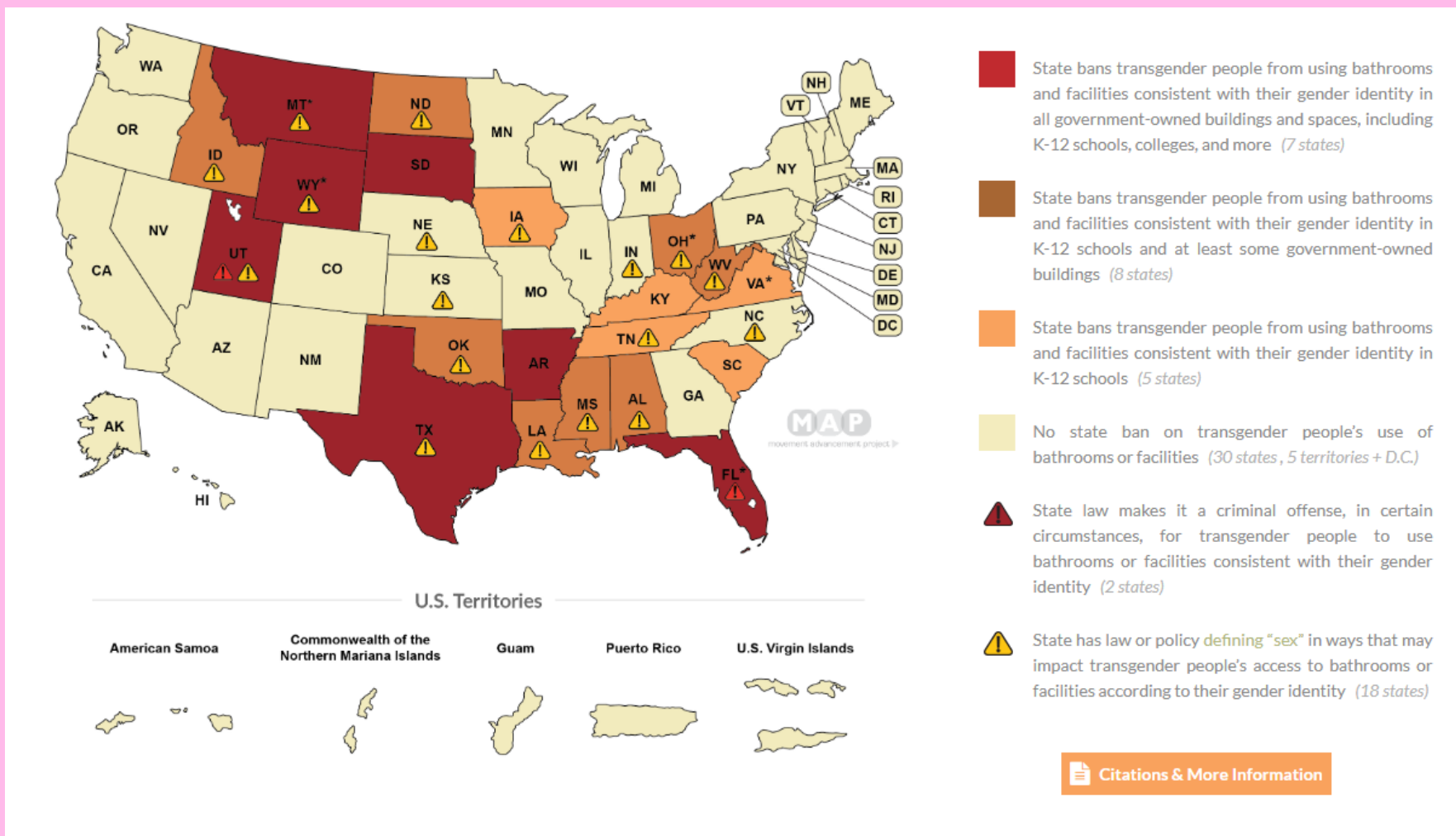
BANS ON MEDICAL CARE FOR TRANS YOUTH

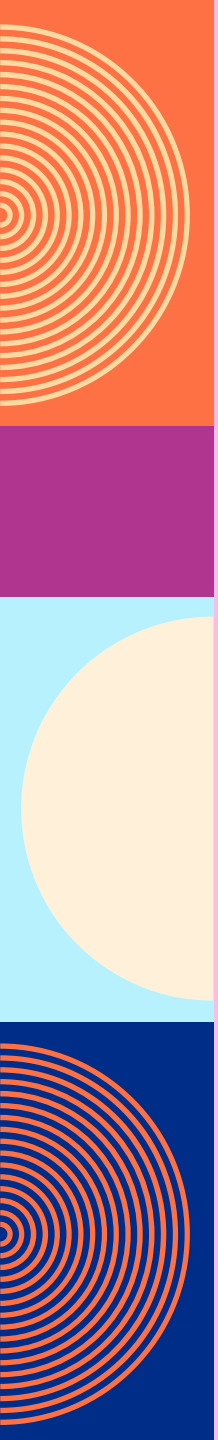


BANS ON MEDICAL SPORTS PARTICIPATION FOR TRANS YOUTH

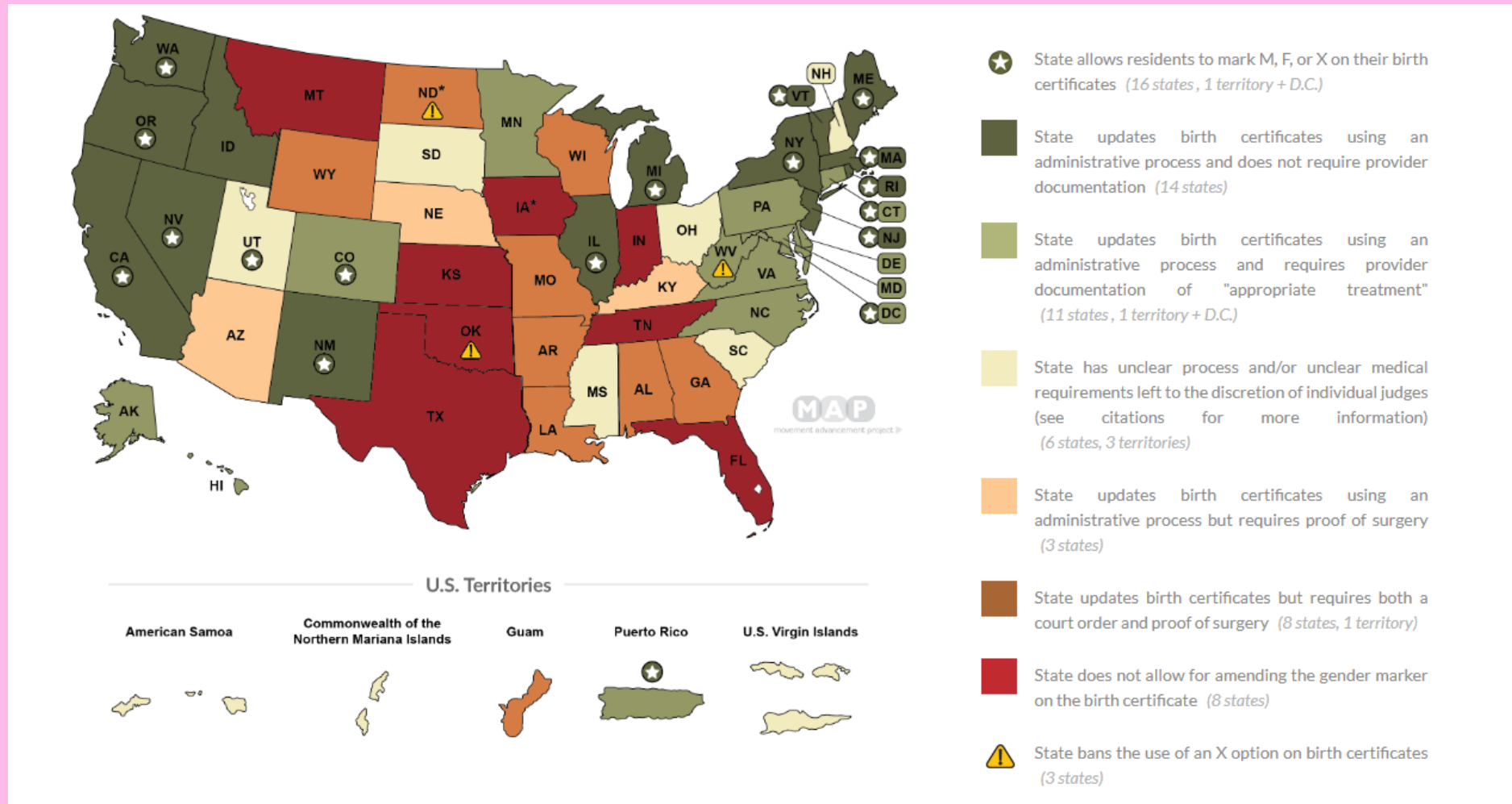


BATHROOM AND FACILITIES BANS

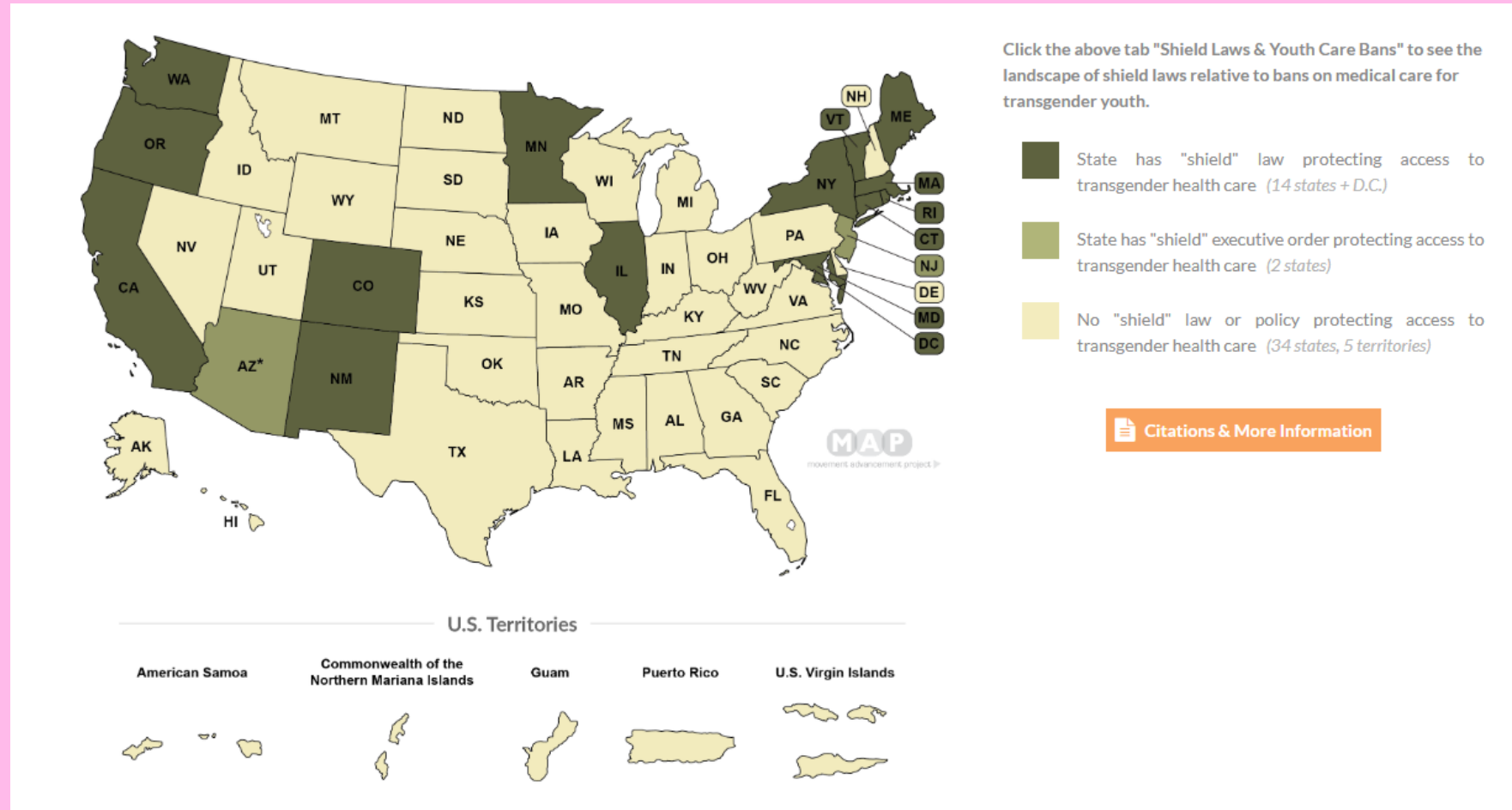
